

STATUTE GOVERNING NOMINATION OF STUDENTS TO MANGALORE UNIVERSITY ACADEMIC COUNCIL

(Framed under Section 30(1)(x) read with Section 40(1)(b) of the KSU Act, 2000)

1. TITLE AND COMMENCEMENT:

- i) This Statute shall be called the “Statute Governing Nomination of Students to Mangalore University Academic Council”
- ii) This Statute shall come into force from the date of assent of the Chancellor.

2. DEFINITIONS:

Unless the context otherwise requires

- a) “Student of a degree course” means a student enrolled for a course leading to a first degree, under any of the Faculties in a constituent college or an affiliated college/institution of Mangalore University.
- b) “Student of a Post Graduate course” means a student enrolled for a course leading to Master’s degree/P.G. diploma under any of the Faculties in a Post Graduate Department, a constituent college or an affiliated college/institution of Mangalore University.
- c) “Student of a professional course” means a student enrolled for a professional degree/PG Diploma in the PG department, a constituent college or an affiliated college/institution of Mangalore University. Professional course means the course offered in the Faculties of Law, Education and Engineering and other degree courses considered as Professional Courses by the Academic Council.
- d) “A Research student” means a student enrolled on full time basis for a course leading to M.Phil/Ph.D degree under any of the Faculties in a PG Departments, a constituent College or an affiliated college/institution of Mangalore University.

3. The Vice-Chancellor shall nominate for a period of two years six students of whom one shall be a student of degree course, one shall be a student of Post-graduate course, one shall be a student of Professional course, one shall be a candidate of the National Cadet Corps, one shall be a candidate of the National Service Scheme and one shall be a candidate of sports on the basis of merit, and of them at least one shall be a women and one a research student.

Provided that no student shall be eligible for nomination:

- a) If his/her name does not appear under rolls of the University or a college affiliated to University.
- b) If he/she is not doing a course in the University or college affiliated to University leading to a degree of the University.
- c) If he/she is taking examinations as an external candidate or through correspondence course or studying in a morning/evening college.
- d) If he/she fails to complete a course in six years.

4. The nomination shall be made in the manner herein prescribed:

The Registrar shall in the month of August of every year shall sent communication to Principals of constituent and affiliated college/Institution, the chairperson of P.G. department, Director of Physical Education to recommend the names of the eligible students as follows:

- i) The principals of the constituent and affiliated colleges/institutions of the University shall forward to the Registrar, by the end of 31st August of every year, the name of one outstanding student of degree courses having regard to his/her performance in the qualifying/University examinations along with a brief bio-data with the details of marks and rank secured if any.
- ii) The Chairperson of Post Graduate Departments of the University, the Principals of the constituent and affiliated colleges/institutions of the University, shall forward to the Registrar, by the end of 31st August of every year, the name of one outstanding student of the Post Graduate course having regard to his/her performance in the qualifying examination for admission to the Post Graduate course and/or his/her performance in the first year examination of the Post-Graduate course along

with a brief biodata with details of marks, rank secured if any, and the name of one outstanding research student based on the performance in the qualifying examination, research publications etc.

- iii) The Chairperson of Post Graduate Departments of the University and the Principals of the constituent and affiliated colleges/institutions of the University, offering professional courses shall forward to the Registrar, by the end of 31st August of every year, the name of one outstanding student of the professional courses having regard to his/her performance in the qualifying University examination along with a brief biodata with details of marks, rank secured if any, and the name of one outstanding research student based on the performance in the qualifying examination, research publications etc.
- iv) The Principals of the constituent and affiliated college/institutions of the University having NCC units, shall forward to the Registrar, not later than 31st August of every year, the name of one outstanding NCC cadet along with brief biodata regarding his/her performance in NCC Programme.
- v) The Chairperson of the Post Graduate Departments of the University and the Principals of the constituent and affiliated college/institutions having NSS units, shall forward to the Registrar, not later than 31st August of every year, the name of one outstanding NSS student volunteer along with a brief biodata with details of his/her performance in NSS Programme.
- vi) The Director of Physical Education of the University and the Principals of the constituent and affiliated college/institutions shall forward to the Registrar, by the end of 31st August of every year, the name of one outstanding sportsman/sportswoman along with a brief biodata with details of his/her performance in sports/games/athletics.
- vii) There shall be an advisory Committee constituted by the Vice-Chancellor consisting of the following members:
 - a) Senior most Dean of Faculty as Chairman
 - b) One Principal of an affiliated college
 - c) One Principal of the Constituent College

- d) One Academic Council Member
- e) Director of Students Welfare
- f) Director of College Development Council
- g) Director of Physical Education
- h) N.S.S. Co-ordinator
- i) The Commandant, NCC group Head Quarters or his nominee
- j) The Registrar shall be the Convener
- k) One Member of the Syndicate

The Committee shall scrutinize the recommendations made by the Chairpersons of Departments of Studies and Principals of colleges, category wise in detail, and prepare separate panels of three names each, in the order of merit, under the categories 4(i) to 4(vi).

Each panel shall comprise not less than one girl-student. If any girl-student is not recommended by the Principals of Colleges and Chairpersons of the P.G. Departments under a particular category, such a panel can comprise boy-students only. All the panels so prepared by the Committee shall be sent to the Vice-Chancellor.

The Vice-Chancellor shall nominate to the Academic Council one student each from the panel prepared by the Committee.

5. Provided, out of the nominations to be made under clause 4(b) and (c), one shall be a research student and out of the nominations to be made under clause 4(a) to (f), one shall be a woman.
6. **Cessation of membership:** A Student nominated to the Academic Council under clause 4 above, shall serve as members of that body for a period not more than two years or till he/she ceases to be on the attendance rolls of the University P.G. Departments/a constituent college or an affiliated college/institution which nominated him/her.
