Day 2, Technical Session 6 TIME: 3:45 PM -5:00 PM

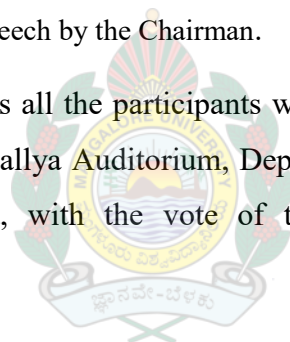
