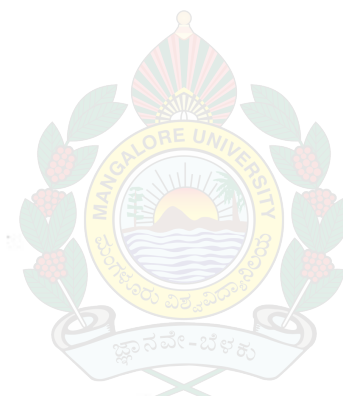

Hours of Instructions: 3/Week


#### Course Rationale:

- Delineation of different aspects of research area
- Formulation of research questions and critical reflection
- Methodological requirement of research writing

There shall also be a Viva towards the end of course work in which the researchers' ability to handle ideas and abstractions, knowledge about the subject area, analytical and presentation skills, critical reflections among others will be assessed.
