- E-source for journals and books was subscribed by the University and extended to students for widening the learning resource base. About 23,378 journal access in the library.
- Entire campus is configured as of Virtual Local Area Networks (VLAN). The connectivity within the department is extended through CAT5/CAT6 UTP cabling, while connectivity across building is established through OFC backbone.
- Core switch at the computer centre provides high speed switching required across the campus network. The switch in the Department/Office/Building is used to provide wired connectivity to class rooms/ faculty rooms / Labs etc.
- The internet access is made available to all users through wired ethernet outlets and campus wide Wi-Fi (Wireless) network.
- Student project work in PG programmes was introduced.
- Faculties were trained to use the examination software.

- Open electives system was introduced which gave the mobility to students to take the courses in departments other than the department in which he/she is likely to get the degree.
- Introduced innovative courses such as Fire and Safety Management, Human Consciousness and Yogic Sciences.

- The results are notified within shortest possible time and whole process is computerised.

**Title of the Practice 1:**

1. Statistics clinic– Integral part of research curriculum

**Objectives**

1. To adopt a scientific approach to study any problem.
2. To develop analytical skills for collection, experimentation and analysis of data.
3. To learn to prepare a scientific report.

**Context**

At the research level, not all the students are exposed to statistical methods to be adopted in their research programmes. Majority of the students select the topics at random without going into the details of methodology involved in research. Therefore, it is always advised to consult a statistician to design the sample/volume and sampling methods before proceeding for the collection of data/sample. The interpretation of gathered data in the absence of suitable statistical treatment may lead to improper conclusions. Therefore, exposure of researchers to basics of statistics and use of statistical packages knowledge becomes essential and forms the integral part of research.

**The Practice**

- a) Preliminary preparatory work: A co-ordinator was appointed by the University to organize a workshop for the benefit of research scholars of all the disciplines of the University. A circular was sent to all the departments regarding the date of commencement of the course, duration, course content with an intimation to the Registrar.
- b) Conduct of the course: General topics such as: qualities of researcher, selecting a research problem, collection of literature in the chosen topic etc. were dealt in common to the researchers of all the disciplines.
- c) The research design, hypothesis, methods of research, sample size determination, collection and presentation of data, analysis and interpretation of the obtained data were also discussed in common. The use of statistical packages were discussed for the benefit of the researchers belonging to science and humanities groups separately.
- d) The computation and statistical methods discussed were: Determination of sample size, different sampling methods, testing. The independence of attributes, use of SPSS.

### **Evidence of success**

An enhance in the confidence level of the students was noticed after the workshop in designing methodology, collection of data, particularly in employing sampling methods. The participation in the workshop made them to survey the literature and the presentation of the data in a scientific manner.

The feedback collected from the researchers at the end of the workshop, revealed the importance of learning statistics/computer and their application in designing the research proposal.

### **Problems Encountered and Resources Required**

There was an initial fear in learning the statistics particularly, by the students of humanities. However, they were able to overcome the fear when they were exposed to simple methods of learning and applying statistics and computer in their research. The students were often assisted by the faculty members in designing their research problems.

### **Title of the Practice 2:**

Best Practices for Activation and Outreach -Sports programmes

#### **Objectives**

- Sports have a profound impact on individuals, the institution as a whole, as well as the community.
- Sports are a powerful and transcendent. It can bridge gaps, bring people with relatively nothing in common together, and gives many participants unbelievable, life-altering opportunities.
- Highly structured sports programmes, deliberate practice devoted to sports-specific skill development.

#### **Context**

Sports programmes of Mangalore University is committed to the holistic development of youth through and in sport, by focusing on the meaningful relationships, activities and settings that enrich the personal assets of each young sports persons across the entire individualized athletic development pathway. Through collaborative skill training, distinctive services and programs, our evidence-informed and sports person-centered focus will help each sports person to develop character, competencies in sport and life, confidence and meaningful connections with adults and peers, while establishing a foundation for personal development and long-term enjoyable participation and achievement in sport. We encourage all sports organizations, programs, parents and other stakeholders to embrace and promote, sustainable, healthy, safe and enjoyable sports participation and optimal athletic performance and achievement.

#### **The practice**

1. Mangalore University proposes to award sport talent scholarship to degree students of Mangalore University. The scholarship amount shall be rupees one thousand five hundred per month.
2. University sponsorship for Sports Excellence is a special sponsorship reserved for outstanding talents who could bring laurels to the University, state, and the nation by way of participating in international

events.

3. One seat is reserved under each faculty in the University teaching departments and PG courses in affiliated colleges for Mangalore University sports persons with outstanding achievements.
4. Specified Mangalore University Inter-collegiate tournaments would be organized in two rounds namely preliminary and championship round.
5. Mangalore University will roll out affirmative programmes for differently abled persons to enable them to take to sports with confidence, realize their potential without inhibition and rise to the glory they are capable of.
6. We have a vast array of indigenous games which are integral to the cultural inheritance of Mangalore University area. It is to secure recognition for indigenous/traditional games in which we have a natural cultural advantage, and which advance community pride and self –confidence.

### **Evidence of success**

- Increasing student's knowledge in sports and refining their leadership skills.
- Mangalore University has won several medals in inter University competitions.
- Our Inter-collegiate sports program is one of the best, in the state. As an example, in 2014-15 alone, participation of students has increased because of new system called preliminary and championship round.




