The Co-ordinator of the IQAC welcomed the members and introduced the special invitees of the committee.

Agenda 1: Ranking of Universities - Criteria Inputs/Approval

NAAC has devised the Criteria for ranking the Universities in the State, and the Principal Secretary Department of Higher Education has directed to send the format of these criteria to all the Vice Chancellor's of State Universities to get their valuable inputs about this matter. Accordingly, the Executive Director Karnataka State Higher Education Council has sent this format to our University to get the opinion of Honourable Vice Chancellor. The matter was placed before the Internal Quality Assurance Cell Committee for discussing the criteria given in the format. The matter was discussed and members gave their inputs. It was decided to the consolidate these inputs and forward the same to Higher Education Council for further action.

Agenda 2: Ranking of Institution and accreditation - Specific inputs

Ministry of Human Resource Development, Government of India as initiated the process of consultation for formulating New Education Policy (NEP). Ministry is interested to hold thematic consultations including the "Ranking of Institution and Accreditations". The write up on this theme is forwarded to the University by the Director, NAAC, Bangaluru, advising the University to conduct a special meeting of IQAC involving experts, academics, industry representatives, and all other stake holders. Therefore, the IQAC committee meeting was held and the matter was discussed thoroughly; specific inputs were collected from the Honourable members. It was also decided to consolidate these inputs and forward the same to the Director, NAAC, Bangaluru for further action.

Agenda 3: AQAR - Information from the department

The Co-ordinator asked the opinion of the committee regarding the collection of information from the department to prepare the Annual Quality Assurance Report for the year 2014-15, being the completion of first year after NAAC accreditation. The committee agreed to initiate the process.

Agenda 4: Online student feedback

It was decided to introduce online student feedback collection system. The Chairman of the committee, instructed to go ahead with that through University Web Portal. Before introducing online collection system the present system of feedback collection shall be continued.

Agenda 5: Any other matter with the permission of the Chair

The Co-ordinator requested the Chairman to nominate the student members to IQAC as per the guidelines of NAAC. It was decided to nominate two student members, one Research Scholar and one Post Graduate Student.
