## MANGALORE UNIVERSITY

### REGULATIONS GOVERNING CONDUCT OF SPECIAL EXAMINATIONS FOR POST-GRADUATE/ UNDER-GRADUATE/ P.G. DIPLOMA/ DIPLOMA/ CERTIFICATE PROGRAMMES OF MANGALORE UNIVERSITY IN THE FACULTIES OF ARTS, SCIENCE, EDUCATION AND COMMERCE

*(Framed under Section 44 (1) (c) of the KSU Act 2000)*

**Preamble:** As per the existing Regulations governing Post-Graduate, Under-Graduate, P.G.Diploma, Diploma and Certificate Programmes in the faculties of Arts, Science, Education and Commerce of Mangalore University, examinations are being conducted for odd/even semesters or annually. The students who represent the University at the Zonal/National/International level in Sports/NCC/NSS/ Cultural/Scouts & Guides and similar such activities and are unable to attend the regular examinations conducted during the period of participation have approached the University to conduct special examinations for them in order to avoid lose of academic years for them. Therefore, the Academic Council and the Syndicate of Mangalore University have decided to conduct special examinations. Hence, these Regulations.

#### **1. TITLE AND COMMENCEMENT:**

- i. These regulations shall be called Regulations governing conduct of special examinations for Post-Graduate/Under-Graduate/P.G. diploma/ Diploma/ Certificate programmes of Mangalore University in the faculties of Arts, Science, Education and Commerce.
- ii. These regulations shall come into force from the date of assent of the Chancellor.

2. **Provision for conducting Special Examinations:** For those students who are unable to attend the regular examinations as they will be representing the University at the Zonal /National /International level in Sports /NCC /NSS /Cultural /Scouts & Guides and similar such activities as recognized by Mangalore University will be given an opportunity to appear for special examinations conducted for odd/even/annual schemes. However, the selected students shall obtain prior permission from the University before going to participate in the above events to become eligible to appear for the Special Examination. The schedule for conducting special examination shall be as prescribed by the University from time to time.
