STATUTE GOVERNING THE APPOINTMENT, TERM OF OFFICE, EMOLUMENTS, CONDITIONS OF SERVICE, POWERS AND FUNCTIONS OF THE DIRECTOR OF STUDENT WELFARE

(Framed under Section 40 (1) (o) and (p) read with Section 22 of the KSU Act 2000)

1. TITLE AND COMMENCEMENT:

- i) This statute shall be called "the statute governing the appointment, term of office, emoluments, conditions of service, powers and functions of the Director of Student Welfare"
- ii) This statute shall come into force from the date of assent of the Chancellor.

2. APPOINTMENT, TERM OF OFFICE, EMOLUMENTS AND CONDITIONS OF SERVICE:

2.1 The Syndicate shall recommend to the Chancellor a person from the cadre of Professor or Reader, if suitable person from these cadres is not available a person from the cadre of Lecturer who has put in not less than 10 years of service, to the Chancellor for appointment as the Director for a period of three years at a time. Such person shall work in his/her own pay and scale and shall be governed by other conditions of service as applicable to other employees of the University.

2.2 When the post of Director becomes vacant or when the Director is on leave and unable to perform his/her duties for any other reasons, such duties shall be performed by a person appointed by the Syndicate for a period not exceeding six months or until the post is filled or the Director resumes his/her duties whichever is early.

3. POWERS AND FUNCTIONS:

He/She shall

- 3.1 be a whole time Officer of the University.
- 3.2 handle funds, fellowships and such other facilities meant for the welfare of students as per the rules/regulations, guidelines provided and be responsible for audit and accounts of such funds.
- 3.3 be the convenor of such of those committees constituted for award of medals, prizes scholarships etc. for the welfare of students.
- 3.4 organize Seminars, Literary/Cultural Activities and such other programmes for the development of personality of the students.
- 3.5 visit the Constituent/Affiliated Colleges to look after the facilities provided for the welfare of the students and make suggestions to create necessary infrastructure/facilities.
- 3.6 call a meeting of the Student Welfare Officers of the Affiliated/Constituent Colleges twice a year and ascertain the problems of the students and bring them to the notice of the concerned authorities of the University and make efforts to solve their problems.

3.7 REPEAL AND SAVINGS:

The existing Statute of Mysore University adopted at the time of formation of Mangalore University shall stand repealed.
