STATUTE GOVERNING THE ESTABLISHMENT OF THE POST GRADUATE CENTRE, CAUVERY CAMPUS, CHIKKA ALUVARA, KUSHALNAGAR, KODAGU DISTRICT.

(Framed under Section 40(f) and (j) of KSU Act 2000)

PREAMBLE:

Mangalore University was established on 10th September 1980 to cater the needs of higher education in the districts of undivided Dakshina Kannada and Kodagu. The Kodagu District is separated from the coastal districts by Western Ghats and the students of Kodagu district were finding it difficult to have an easy approach to Mangalore University Campus at Mangalagangothri. Therefore to fulfil the longstanding demand of the people of Kodagu District the Post-Graduate Centre, Cauvery Campus was established at Madikeri in 1998 through a Statute. To begin with the Cauvery Campus was located in the premises of Field Marshal K.M.Cariappa College – a Constituent College of Mangalore University. Three P.G Departments of Studies viz., Environment and Ecology, Microbiology and Bio-Chemistry were established in the Cauvery Campus, Madikeri. Since there was not enough space to develop a full-fledged P.G. Centre in the College Campus, Government of Karnataka was requested to grant about 100 acres of land at Kodagu District. In response to this the Government vide Order No.Land(2)/12/2002-03 dated 09.03.2007 granted 70.47 acres of land at Chikka Aluvara, Kushalnagar, Somvarpet Taluk to house the P.G. Centre, Cauvery Campus of Mangalore University. The Goyt, has also sanctioned Rs.2.00 crores for development of the P.G. Centre. Hence this Statute.

1. TITLE AND COMMENCEMENT:

- i) This Statute shall be called as "The Statute governing the establishment of the Post Graduate Centre of Mangalore University, Cauvery Campus, Chikka Aluvara, Kushalnagar, Kodagu District".
- ii) This Statute shall come into force from the date of assent of the Chancellor.
- **2**. The Post Graduate Centre, Cauvery Campus shall be established at the following address:

Mangalore University Post Graduate Centre Cauvery Campus, Chikka Aluvara Kushalnagar, Somvarpet Taluk Kodagu District.

- 3. The Post-Graduate Centre for Environment and Ecology and Post-Graduate Departments of Studies in Microbiology and Biochemistry at Cauvery Campus, Madikeri stand shifted to the Post Graduate Centre, Cauvery Campus, Chikka Aluvara.
- 4. The contents of the following two existing Statutes along with the establishment of the departments and the posts created therein shall stand incorporated into this Statute.

- (a) The Statute Establishing the Post-Graduate Centre for Environment & Ecology, Cauvery Campus, Madikeri (assented by the Chancellor on 28.01.1998 as communicated in Govt. letter No.ED1 UDS 96 dated 6.2.1998 and notified on 9.7.1998).
- (b) The Statute relating to the Establishment of Departments and creation of posts in the P.G. Centre at Madikeri (assented by the Chancellor on 12.2.1998 as communicated in Govt. letter No.ED4 UDS 97 dated 23.2.1998 and notified on 18.3.1998).
- **5.** Additional Post-Graduate Departments of Studies may be established in future at the P.G.Centre.

6. REPEAL AND SAVINGS:

The statute stated under 4(a) and (b) are hereby repealed, provided that the said repeal shall not affect the previous operation of those statute or anything duly done or suffered thereunder.
